
### **Evaluation first principle**

- Take lessons of past EU actions into account
- Assess performance against initial expectations
- Decide on next steps
- First step of evaluation: call for evidence (20/06/2024-06/09/2024)




### Statistics feedback call for evidence: 87




#### By category of respondent

- Business association: 24 (27.59%)
- Non-governmental organisation (NGO): 24 (27.59%)
- Public authority: 13 (14.94%)
- Other: 10 (11.49%)
- **EU** citizen: 8 (9.20%)
- Environmental organisation: 2 (2.30%)
- Academic/research Institution: 2 (2.30%)
- Company/business: 2 (2.30%)
- Trade union: 1 (1.15%)
- Consumer organisation: 1 (1.15%)





### **Better Regulation**



- Evaluation will provide an evidencebased assessment of whether the CFP Regulation is still fit for purpose or where lessons can be learned for improving.
  - What has happened?
  - Why has it happened?
  - How much of this is linked to EU intervention?
- Five evaluation criteria:

effectiveness; efficiency; relevance; coherence; EU added value.





### Why a full evaluation?

The "Fisheries and Oceans package" adopted by the Commission in February 2023 reported on the implementation of the CFP to date and launched a dialogue going further into detail of key challenges for Europe's fisheries today.

Building upon this dialogue and linked to:

- <u>Ex-post evaluation of the European Maritime and Fisheries Fund:</u>
- <u>Mid-term evaluation</u> of the European Maritime, Fisheries and Aquaculture Fund:
  - 42 entries call for evidence; 16 entries public consultation
- Evaluation of the landing obligation
- Evaluation of the <u>Sustainable fisheries partnership agreements</u>



### **Current political context**

• In Political guidelines for the next European Commission 2024 – 2029

>> "I will appoint a Fisheries and Oceans Commissioner tasked with ensuring the sector remains sustainable, competitive and resilient and with upholding a level playing field for the European fisheries chain."

• Fisheries and Oceans Commissioner: nominated Costas Kadis - public hearings at European Parliament early November.

>> "You will complete and follow up on the comprehensive evaluation of the CFP, with particular attention to its economic, environmental and social dimensions." <u>Mission letter</u>.

• European Oceans Pact ensuring coherence across all policy areas linked to the oceans

>> "Focus on supporting resilient and healthy oceans and coastal areas, promoting the blue economy, managing the use of our seas and oceans coherently and developing a comprehensive agenda for marine knowledge, innovation and investment'"



### Planning

- Supporting study to be launched October 2024
- Public stakeholder consultation by the end of 2024
- Dedicated sessions with Advisory Councils
- Finalisation of study October 2025
- Final product is the evaluation report a staff working document written by the Commission
- Evaluation findings feed into the next step of the cycle decisionmaking



### NWWAC ADVICE ON CFP REVIEW 24 October 2022 & Call for Evidence 2024

- Objectives over tools, amend if necessary
- Flexibility of the policy when changes happen
- Post-Brexit landscape should be considered and more coherency between UK and EU waters
- More effective advice feedback
- Reaching MSY and considering MSY volatility
- MAPs should be amended according to specific cases
- Landing obligations should be better enforced

- Inter-disciplinary approach where socioeconomic factors will be included
- Simplify the delivery mechanisms and administrative burden
- There is a lack of data, make better use of data that is available
- See if the tools still fit the purpose, and if there is a better tool available
- Ensure a level playing field
